This is to inform you that representatives of AirCell, Inc. ("AirCell") participated in *ex parte* meetings on November 10, 2004 to discuss issues in the above-referenced air-to-ground ("ATG") proceeding. Specifically, Jack Blumenstein, Chairman and CEO, Bill Gordon, VP for Government Affairs, Grant Saroka, consultant to AirCell, and I, counsel to AirCell, participated in two meetings, as noted below, with Commission staff:

- Ed Thomas, Julius Knapp, Jim Schlichting and George Sharp, all of the Office of Engineering and Technology ("OET"), attended the first meeting. Ed Lasse, Michael Delachapelle, Howard Symons and Carlos Nalda, representing Connexion by Boeing, also attended this meeting.
- Kathy Harris, Tom Derenge, Richard Arsenault, Gregory Vardas and B.C. Jay Jackson, of the Wireless Telecommunications Bureau, and Jim Schlichting, George Sharp and Salomon Satche of OET, attended the second meeting.

During both meetings, AirCell reviewed the attached presentation. In particular, AirCell explained how its proposal would permit the provisioning of deck-to-deck coverage (including the Denver and Salt Lake City airports), responded to the most recent filing of Verizon Airfone, and discussed out-of-band emission limits. At the second meeting, AirCell also discussed the importance of providing for competition in the ATG band, and provided attendees with a copy of a second presentation, "Deployment of Two Cross-Polarized Systems in the ATG Band," previously filed in this docket on October 26, 2004. Finally, on the same day, I had a brief telephone discussion with Jennifer Manner, office of Commissioner Abernathy, regarding the same issues covered in these two meetings.
