

**The most compelling UNE: Legacy Dark Fiber Transport**, innovation, competition, new capacity.

- Impairment relates not to Special Access Tariff, but to **physical presence of third party fiber** or **cost to self-deploy**.

**DF Transition Plan Linked to ILEC Cooperation**

- Cost to deploy and terminate fiber highly dependant on ILEC receptivity.
- Milestone driven approach: conversion to commercial IRU or roped and rodded duct made available.

### **EEL Criteria Applied to Loops Defeats Wholesale Competition & Data Services**

- Would eliminate wholesale service delivery and data-only offerings from competitive ecosystem.
- Federal Courts have already said that Act defines telecommunications service, no basis for restriction.
- At a minimum, need a carve out for facilities-based wholesalers. Alpheus' customer's have switches, not Alpheus. If attestation of use required, network hegemony returns to ILEC.

### **Grandfather Legacy Dark Fiber Loops for 48 months**

- Prevents interruption in customer service.
- Sets in place an orderly transition while replacement of unimpaired transport routes are underway.
- Building Access issues are key factor for loop impairment...Grandfather status would allow Building Access Docket to resolve these issues.
