**COMMENTS OF COOK COUNTY BROADCASTING OF MINNESOTA**

Cook County Broadcasting of Minnesota ("CCBM"), pursuant to Section 1.420 of the Commission's Rules and by its counsel, hereby submits these Comments in connection with the Notice of Proposed Rule Making issued in this proceeding.<sup>1</sup> The NPRM proposes the allocation of Channel 224C at Grand Portage, Minnesota as that community's third local service.

CCBM reaffirms that the proposal will serve the public interest. The proposal will result in a preferential arrangement of allotments consistent with the FM Allotment Priorities by providing Grand Portage with its third local aural transmission service.<sup>2</sup> Should the Commission implement the proposed change to the FM Table of Allotments, CCBM hereby states that it will timely participate in any auction for the new allotment, file the necessary application for a construction permit for a new station, and will construct the new facility in a timely manner.


