PETITION FOR RULEMAKING

Georgia-Carolina Radiocasting Company, LLC ("GCR"), by its attorney, hereby requests the Commission amend the FM Table of Allotments as follows:

<u>Community</u>	<u>Current</u>	<u>Proposed</u>
Elberton, GA	286A	---
Union Point, GA	---	286C2

In support thereof, the following is stated:

GCR is licensee of Station WEHR(FM), Elberton, Georgia. GCR desires to upgrade its station to a Class C2 facility to enable it to improve and increase its area-wide coverage.

As seen in the attached Technical Comments, it is proposed that this objective be accomplished by allowing GCR to change communities of license from Elberton, Georgia to Union Point, Georgia. The Union Point reference coordinates are mutually-exclusive with the current reference coordinates for Station WEHR(FM). Therefore, this proposal complies with Section 1.420(i) of the Commission's rules. 47 C.F.R. § 1.420(i).

Additionally, Union Point is an independent community, and is not within the urbanized area of any community. As seen in Attachment 1, Union Point is a census designated place with a Year 2000 population of 1669 persons. Information available from the Union Point City Hall¹ confirms that the community is incorporated, with its own Mayor, 6-member City Council, volunteer Fire Department, 10-member Police Department, and water, sewer, gas, and sanitation services. As seen in Attachment 2, the allotment change can be accomplished in full accord with all existing allotments and stations. Moreover, the loss area is well served with five or more full-time stations.

Adoption of this proposal will result in a preferential arrangement of allotments. Elberton currently is served by three aural services (WEHR(FM), WSGC(AM) (1400 Khz) and WSGC-FM (Channel 221A)), and after adoption of this proposal, the community will continue to be served by one full-time aural service.² In contrast, no stations currently are allotted to Union Point. Therefore, this allotment will result in a new first aural service for Union Point, which is "Priority (3)" under the Commission's allotment priorities.³

³ The Commission's has an established allotment criteria which was set forth initially in Revision of FM Assignment Policies and Procedures, 90 F.C.C.2d 88 (1982), which establish the following allotment priorities:

- (1) first full-time aural service
- (2) second full-time aural service
- (3) first local service
- (4) other public interest matters;

Adoption of this proposal will be in the public interest. Approval of this proposal will allow GCR to improve the service that it provides to the public through operation of WEHR(FM) by greatly increasing its service area and overall population served. GCR pledges expeditiously to apply for and to construct this proposed facility when this proposal is granted by the Commission.

Accordingly, Georgia-Carolina Radiocasting Company, LLC respectfully requests that this Petition be adopted; and that the Commission issue a Notice of Proposed Rulemaking to amend the FM Table of Allotments as specified above, and accept comments thereon.



Technical Comments
Rule Making Request
To Reallocate 286A Elberton, GA
To 286C2 Union Point, GA
March 2003

These Technical Comments are prepared on behalf of Georgia-Carolina Radiocasting Company, LLC ("GCRC") which is the licensee of WEHR (FM), Elberton, GA. WEHR operates as a Class A facility with 6 KW from 100 M HAAT. GCRC is requesting that Channel 286A at Elberton, GA be reallocated to Union Point, GA and be increased to Class C2 and that WEHR (FM) be ordered to Union Point, GA.

ALLOCATION

From the Union Point, GA reference coordinate of North Latitude 33 22 42 and West Longitude 83 00 16 all Section 73.207 spacing requirements are met. An allocation study to substantiate this clearance is being included. The only allocation shortages are to our own facility or proposals this instant request supercedes. A map indicating the 70 dBu uniform terrain 32.6 KM city grade contour is also being included. 100% of Union Point is within the city grade contour.

There is a distance of 71.08 KM between the Union Point allocation reference and the licensed WEHR (FM) site. Section 73.207 requires co-channel class A and C2 stations to be separated by 166 KM; therefore this proposal is mutually exclusive with WEHR (FM).

AREAS AND POPULATION

WEHR (FM) operates as a maximum Class A facility. Within the 60 dBu contour there are 26,638 persons within 2,428.18 SQ KM. From the proposed Union Point allocation reference within the proposed 60 dBu contour there are 104,568 persons within 6,590.22 SQ KM.

ELBERTON AND UNION POINT BROADCAST SERVICES

This instant proposal will be the first broadcast service allocated to Union Point, GA. At Elberton, GA, after WEHR (FM) is removed, two broadcast services will remain. They are WSGC-AM, 1400 kHz and WSGC-FM, 221A.

A study was made to analyze the number of services remaining to the WEHR (FM) loss area. 100% of the loss is served by five or more broadcast services.

TOWN OF UNION POINT, GA

Union Point, GA is located in Greene County, GA . The 2000 Census depicts the city with 1,669 persons. It also lists the area of Union Point, GA as 5.4 SQ KM. The racial makeup of the city is 51.4% White, 46.38% African American. Less than 1% of the population is comprised of Asians and Pacific islanders and other races. Union Point, GA nor any part of the proposed 70 dBu contour are in any urbanized area.

Employment in Union Point is composed of 29% manufacturing, 16.4% educational and health and social services and 13.9% retail trade.


Bethel Christian School is a private primary/middle school at Union Point with 70 students enrolled. Union Point Elementary is a public school with 504 Students.


