On May 9, 2005, on behalf of Eschelon Telecom, NuVox Communications, TDS Metrocom, XO Communications, and Xspedius Communications, the following persons met with the FCC staff to discuss the anticompetitive impacts of the proposed AT&T/SBC merger: Brad Mutschelknaus, Edward A. Yorkgitis, Jr., and Tom Cohen of Kelley Drye & Warren LLP; Gary Reback of Carr & Ferrell, LLP, Dr. Simon Wilkie, economist and Associate Instructor at California Institute of Technology, and Heather Gold and Chris McKee, of XO Communications. FCC staff present were: C. Anthony Bush, Ann Bushmiller, Neil Dellar, Joel Rabinowitz, Michelle Ellison, and Karen Onyeije of the Office of General Counsel; Kent Nilsson of the Office of General Counsel and Office of Engineering & Technology; Rodger Woock, Marcus Maher, Pam Megna, Paul Zimmerman, Gail Cohen and Ben Childers of the Wireline Competition Bureau; Bill Dever, Jon Minkoff and Takeo Zijima of the Wireline Competition Bureau, Competition Policy Division; Craig Stroup of the Wireline Competition Bureau, Industry Analysis & Technology Division; and Chuck Needy of the Office of Strategic Planning.

At the meeting, after an introduction by Mr. Mutschelknaus about the importance of the wholesale market to recent Commission policy and rules on competitive issues, Dr. Wilkie discussed a preliminary economic analysis of the contemplated merger's anticompetitive effects primarily in that market, based upon CLEC-provided and publicly available data.
