

REPLY TO COMMENTS OF ACCESS.1  
LOUISIANA HOLDING COMPANY, LLC

I, Charles Crawford, respectfully submit this Reply to  
Comments of Access.1 Louisiana Holding Company, LLC  
"Access.1" in the above captioned proceeding.

DISCUSSION

In their Reply Comments to the above captioned  
proceeding, Access.1 says at pages 10 and 11, "In  
addition, the withdrawals of interest in the rule making  
proceedings from Team Broadcasting Company, Inc.; Noalmark  
Broadcasting Corporation; Logansport Broadcasting, and  
Charles Crawford are silent or ambiguous as to whether they  
will receive compensation from another party, such as one  
of the licensees agreeing to accept modification of their  
authorizations."

In response to the above quote from Access.1, I would like to make two points of clarification. First of all, the withdrawal to which Access.1 refers to is Center, Texas, MB Docket No. 04-317 and not the current proceeding. In the current proceeding, MB Docket No. 05-47, Tennessee Colony and Groesbeck, Texas, I support and should the Commission grant either or both of these allotments, I will apply for either or both of them and after they are authorized, will promptly construct these new facilities. Secondly, concerning my withdrawal in MB Docket No. 04-317, Center, Texas. Access.1 says I am silent or ambiguous as to whether I will receive compensation from another party. This is an inaccurate statement. In my Sworn Affidavit provided along with my Motion to Dismiss Petition for MB Docket No. 04-317, Center, Texas, I say, "I hereby certify that I have not nor will not receive, either directly or indirectly, any money or other consideration in connection with the dismissal of the Petition/ expression of interest." This is an unequivocal statement to which I stand by.

And finally, in the current proceeding, the public interest would be served by allocating Channel 299A to Groesbeck, Texas as that community's first local FM service

and Channel 300A to Tennessee Colony, Texas as that community's first local FM service. And should the Commission decide to grant Channel 299A at Groesbeck, Texas and or grant Channel 300A to Tennessee Colony, Texas, and after they are authorized, I will promptly construct these new facilities.

The factual information provided in these Reply to Comments of Access.1 Louisiana Holding Company, LLC is correct and true to the best of my knowledge.


