On June 15, 2005, on behalf of Cbeyond Communications, SAVVIS Communications, and XO Communications, the following persons met with Commissioner Michael Copps and Jessica Rosenworcel of his staff and with Michelle Carey of Chairman Kevin Martin's staff: Julia Strow of Cbeyond Communications, Joanna Lowry of SAVVIS, Heather Gold of XO Communications, Brad Mutschelknaus and Thomas Cohen of Kelley Drye & Warren LLP, Christopher Wright of Harris, Wiltshire & Grannis, LLP, and Dr. Simon Wilkie, economist and Associate Instructor at California Institute of Technology.

At the meeting, after an introduction by Mr. Mutschelknaus about the importance of the wholesale market to recent Commission policy and rules on competitive issues, Dr. Wilkie discussed a preliminary economic analysis of the contemplated merger's anticompetitive effects primarily in that market, based upon CLEC-provided and publicly available data.
