

By the Acting Chief, Competition Policy Division:

On June 3, 2005, the Commission released a First Report and Order and Notice of Proposed Rulemaking, FCC 05-116 in the above captioned proceeding. This Erratum corrects this document as indicated below:

1. In paragraph 1, in the second sentence, we replace "LEC" with "local exchange carrier (LEC)".

28. On page 53, in Appendix C, in footnote 40, we replace “*Id.*” with “15 U.S.C.”.


29. On page 54, in Appendix C, in paragraph 17, in the sixth sentence, we replace “1.500” with “1,500”.
