

(together, the "Joint Petitioners"), hereby submit this Supplement to their Petition for Rule Making, filed on March 21, 2005. In support of their position, the Joint Petitioners submit the following:

The Joint Petitioners requested in their Petition for Rule Making, *inter alia*, that the Commission issue an Order to Show Cause to Haystack Broadcasting, Inc. ("HBI"), licensee of Station KYYT(FM), Goldendale, Washington, in order to change its channel from 300C2 to 272C2.



For the foregoing reasons, the Joint Petitioners withdraw their request for an Order to Show Cause to HBI and urge the Commission to process this proceeding expeditiously.


