Dear Ms. Dortch:

On behalf of Northwest Communications Cooperative ("NCC"), the above-referenced petition is hereby supplemented to include the following information provided by NCC:

1. NCC currently receives \$11.00 per month per access line of Interstate Common Line Support ("ICLS").
2. NCC receives \$57,479 monthly of ICLS, or \$689,748 annualized.
3. Noonan Farmers Telephone Company ("Noonan") currently receives \$12.80 per month per access line of ICLS.
4. Noonan receives \$3,073 monthly of ICLS, or \$36,876 annualized.
5. Estimated that after acquisition of Noonan's assets, NCC will receive \$11.08 per month per access line of ICLS.
6. Estimated after acquisition of Noonan's assets, NCC will receive a \$60,552 monthly amount, or \$726,624 annualized.
