At the meeting, after an introduction by Mr. Mutschelknaus about the importance of the wholesale market to recent Commission policy and rules on competitive issues, Dr. Wilkie discussed a further economic analysis of the proposed mergers' anticompetitive effects primarily in that market, based upon CLEC-provided and publicly available data. A copy of the presentation used at the meeting is attached hereto. Also discussed was the issue of gaining access to information and data underlying Dr. Wilkie's presentation and access to confidential information supplied by the Applicants.
