Dear Ms. Dortch:

On September 8, 2005, Barbara Esbin, Associate Bureau Chief of the Media Bureau, requested that Comcast Corporation ("Comcast") file certain documents that have been submitted to the FTC. In response to Ms. Esbin's request, Comcast hereby submits its organizational charts and personnel directories for inclusion in the record.

Pursuant to the Protective Order<sup>1</sup> adopted in this proceeding, Comcast is submitting these charts and directories in redacted form. They contain proprietary and confidential information. Given the detailed nature of the employee information contained in the charts and directories, other MVPDs, including both parties and non-parties in this proceeding, could use this information to solicit key employees away from Comcast causing the company substantial competitive harm.

Pursuant to the Protective Order, Comcast is filing one copy of the unredacted organizational charts and personnel directories with the Secretary's Office under separate cover, and two copies of the unredacted organizational charts and personnel directories with Brenda Lewis of the Media Bureau. Under the terms of the Protective Order, these documents should not be placed in the public record in this proceeding.


