Dear Ms. Dortch:

On September 8, 2005, Barbara Esbin, Associate Bureau Chief of the Media Bureau, requested that Time Warner Cable file certain organizational charts and personnel directories that have been submitted to the FTC. In response to Ms. Esbin's request, Time Warner Cable hereby submits such documents for inclusion in the record, which have been updated to reflect recent personnel changes.

Pursuant to the Protective Order<sup>1</sup> adopted in this proceeding, Time Warner Cable is submitting these charts and directories in redacted form. They contain proprietary and confidential information. Given the detailed nature of the employee information contained in the charts and directories, other MVPDs, including both parties and non-parties in this proceeding, could use this information to solicit key employees away from Time Warner Cable causing the company substantial competitive harm.

Pursuant to the Protective Order, Time Warner Cable is filing one copy of the unredacted organization charts and personnel directories with the Secretary's Office under separate cover,


