In the applications SBC Communications Inc. ("SBC") and AT&T Corp. ("AT&T") have filed to transfer control of the cable landing licenses and international Section 214 authorizations held by AT&T and its subsidiaries, ¹ SBC disclosed affiliations, by virtue of its ownership interest in Cingular Wireless LLC ("Cingular"), with IDEA Cellular Limited ("IDEA"), an authorized provider of mobile services in certain geographic regions of India. Cingular has advised SBC that, on September 29, 2005, Cingular sold all of its interest in IDEA. ² Therefore, SBC no longer is affiliated with IDEA or any other carrier in India.
