Dear Ms. Dortch:

Julie Salovaara of the Media Bureau has requested that Time Warner Inc. ("Time Warner") file certain confidential Time Warner Cable organization charts into the above-captioned docket associated with the pending transactions involving Time Warner, Comcast Corporation and Adelphia Communications Corporation. In response to Ms. Salovaara's request, and pursuant to the Protective Order¹ adopted in this proceeding, Time Warner hereby submits these documents in redacted form for public inspection.

In addition, Time Warner has filed one unredacted copy of the requested organization charts with the Secretary's Office. Two copies of these documents will also be delivered to Julie Salovaara and Tracey Waldon. Given the detailed nature of the employee information contained in these materials, other MVPDs, including both parties and non-parties in this proceeding, could use this information to solicit key employees away from Time Warner Cable causing the company substantial competitive harm. As these documents contain such proprietary and confidential information, under the terms of the Protective Order, the unredacted documents should not be placed in the public record in this proceeding.
