**REQUEST FOR
SPECIAL TEMPORARY AUTHORITY**

The Commission previously authorized PanAmSat Licensee Corp. ("PanAmSat") to operate PAS-5 at 166° E.L. pursuant to a grant of Special Temporary Authority ("STA").¹ PanAmSat herein requests an STA to continue operating PAS-5 at 166° E.L., in accordance with the terms of its existing STA, following a proposed transfer of control of PanAmSat to Intelsat Holdings, Ltd. ("Intelsat"). PanAmSat is submitting similar filings in connection with the other STAs that it holds.

Contemporaneously with the filing of the instant request, applications are being filed seeking the Commission's consent to transfer control to Intelsat of the space station and earth station licenses held by PanAmSat and by PanAmSat H-2 Licensee Corp. PanAmSat respectfully requests that the Commission process as a group the instant STA request, the transfer of control applications, and PanAmSat's other requests for an STA to continue operating following the proposed transfer of control.
