**WIRELESS TELECOMMUNICATIONS BUREAU REQUESTS COMMENT ON ALLTEL  
PETITION FOR LIMITED WAIVER OF THE DECEMBER 31, 2005 DEADLINE TO ACHIEVE  
NINETY-FIVE PERCENT PENETRATION OF LOCATION-CAPABLE HANDSETS AMONG  
ITS SUBSCRIBERS**

By this Public Notice, we seek comment on a petition for limited waiver filed September 30, 2005 by Alltel Corporation (Alltel)<sup>1</sup> seeking relief from the requirement that it achieve ninety-five percent penetration of location-capable handsets among its subscribers by December 31, 2005, as required by Section 20.18(g)(1)(v) of the Commission's Rules (Ninety-five Percent Penetration Rule).<sup>2</sup> Specifically, Alltel seeks to defer its obligation to comply with the Ninety-five Percent Penetration Rule until June 30, 2007.<sup>3</sup> In support of its request, Alltel cites to the following factors: customer and handset churn rates,<sup>4</sup> reluctance of low-volume and rural subscribers to upgrade their handsets,<sup>5</sup> and the lack of Public Safety Answering Point (PSAP) Phase II readiness.<sup>6</sup>

Commenting parties should address the Alltel Petition relative to the Commission's stated policy that it is critical for all handset-based carriers to meet the final implementation deadline of December 31, 2005 for ninety-five percent location-capable handset penetration, in order to allow all stakeholders (including carriers, technology vendors, public safety entities, and consumers) to have greater certainty about when Phase II will be implemented and ensure that Phase II is fully implemented as quickly as

possible.<sup>7</sup> Further, we seek comment on whether granting the relief requested would be consistent with established waiver standards.<sup>8</sup>

## GENERAL INFORMATION

Comments must be filed no later than October 21, 2005, and reply comments must be filed no later than October 31, 2005. All filings concerning matters referenced in this Public Notice should refer to WT Docket No. 05-XXX.
