SUPPLEMENT

Citicasters Licenses, L.P., licensee of Station WMRN-FM, Marion, Ohio, and CC Licenses, LLC, licensee of Station WSRW-FM, Hillsboro, Ohio¹ (collectively, "Clear Channel"), by their counsel hereby submit the following Supplement in the above-captioned proceeding.²

The purpose of this Supplement is to inform the Media Bureau of a recent development relating to this proceeding. Specifically, on October 1, 2005, the sale of Station WQIO(FM), Mt. Vernon, Ohio from Clear Channel to BAS Broadcasting, Inc was consummated. As discussed in previous pleadings in this proceeding and hereby incorporated by reference, this sale addresses the issues concerning the radio ownership rules in Section 73.3555 raised by The Committee for Competitive Columbus Radio (the "Committee") in this proceeding. Therefore, the Bureau should dismiss Committee's *Petition for Reconsideration* as moot.


