At the request of the Media Bureau, Comcast Corporation ("Comcast") hereby submits additional documents in response to Question III.G of the Commission's December 5, 2005 Information and Document Request ("Request") in the above-referenced proceeding.<sup>1</sup> Because the documents enclosed include highly sensitive commercial data, Comcast submits them pursuant to the Second Protective Order in the docket.<sup>2</sup>


