**STATEMENT FOR THE RECORD**

Southern Stone Broadcasting, Inc. ("Stone"), by its attorneys, hereby respectfully reports the following matters in the above-captioned MB Docket 04-379, to substitute Channel 249C2 for Channel 249C3; re-allot Channel 249C2 from Eatonton to Lexington, Georgia, and modify the license of WMGZ accordingly.<sup>1</sup>

By assignment consummated as of October 31, 2005, the license of WMGZ was assigned by Middle Georgia Communications, Inc. ("Middle Georgia"), to Stone pursuant to File No. BALH-20050523AEO. Southern Stone adopts the statements made by the former licensee, Middle Georgia, and continues to express interest in the allotment; i.e., if the proposal is granted, and the license of WMGZ is modified to specify operations on Channel 249C2 at Lexington, Georgia, Stone will promptly file an application to implement the change, vigorously prosecute the application, and if the


