Dear Ms. Dortch:

Time Warner Inc. ("Time Warner") today submitted additional documents to supplement its document production and responses to the Commission's Information and Document Request dated December 5, 2005.¹ Specifically, the Option Agreement and Sales Agreement relating to SportsTime Ohio and the "License Agreement" referenced in the SportsNet New York Affiliation Agreement were submitted to the Commission as part of the unredacted version of this letter.

The final agreement relating to Carolinas Sports and Entertainment Television ("C-SET") was included with the supplemental documents submitted on March 14, 2006. This continues to be the operative agreement pursuant to which Time Warner Cable ("TWC") systems carry certain Charlotte Bobcats basketball games, as TWC explained in its letter dated March 2, 2006. Specifically, the original 2004 agreement provided that, in the event the C-SET service ceased operating, TWC had the option to elect to automatically amend/novate the affiliation agreement into a direct license for the Bobcats events according to terms contained in Section 22. TWC made that election when C-SET ceased operating, and the affiliation agreement was therefore automatically amended/novated. A copy of the novation letter was also submitted with today's unredacted filing.


