At the request of the Media Bureau, Comcast Corporation ("Comcast") hereby submits a supplemental response to question III.F.1 of the Commission's December 5, 2005 Information and Document Request ("Request")¹ as well as certain additional information concerning the video programming networks in which the company holds an attributable interest. Because the information provided in response to question III.F.1 includes highly sensitive commercial data, Comcast submits this data pursuant to the Second Protective Order in the docket.²


