At the request of the Media Bureau, Time Warner Inc. ("Time Warner") today submitted a supplemental response to Question III(F)(1) of the Commission's December 5, 2005 Information and Document Request relating to certain programming affiliation agreements involving Time Warner Cable Inc. ("TWC") and/or its affiliates. In addition, as a follow-up to the supplemental responses submitted on March 23, 2006, TWC hereby confirms that none of its local origination programming channels, including its various local news channels, are distributed via satellite.


