**PLEADING CYCLE ESTABLISHED FOR COMMENTS
ON THE GEORGIA PUBLIC SERVICE COMMISSION PETITION FOR DECLARATORY
AND CONFIRMATION OF JUST AND REASONABLENESS OF ESTABLISHED RATES**

On April 18, 2006, the Georgia Public Service Commission (GPSC) filed a petition for declaratory ruling seeking clarification that the GPSC is not preempted by federal law from setting just and reasonable rates under section 271 of the Act, 47 U.S.C. § 271, for local switching, high capacity loops and transport, and line sharing. In the alternative, if the Commission finds that the GPSC is preempted from setting rates in this context, the GPSC asks the Commission to find that the rates ordered by the GPSC for high capacity loops and transport and line sharing are just and reasonable, and that BellSouth is obligated to abide by those rates in Georgia. If the Commission instead finds that the rates ordered by the GPSC are not just and reasonable, and that the GPSC is preempted from setting rates in this context, the GPSC asks the Commission to set just and reasonable rates for BellSouth's high capacity loops and transport, and line sharing in Georgia based on the record in the state proceeding the GPSC attached to its petition.

This Public Notice establishes certain procedural requirements relating to consideration of the GPSC's petition. This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in Section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Pursuant to Section 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on the GPSC's petition on or before **May 19, 2006** and reply comments on or before **June 5, 2006**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See Electronic Filing of Documents in Rulemaking Proceedings, 63 Fed. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail.
