Intelsat Holdings, Ltd. ("Intelsat"), PanAmSat Licensee Corp. ("PanAmSat LC"), and PanAmSat H-2 Licensee Corp. ("PanAmSat H-2 LC"), by their attorneys, file this letter pursuant to Section 1.65 of the Federal Communications Commission's ("FCC") rules<sup>1</sup> to update information concerning their above referenced pending application to transfer control of the FCC licenses and authorizations held by PanAmSat LC and PanAmSat H-2 LC (the "Transfer Application").

The Transfer Application was filed on September 30, 2005 and included a request for the transfer of control to Intelsat of licenses granted to PanAmSat LC during the Commission's consideration of the Transfer Application.<sup>2</sup> A new space station license for Galaxy 16 (S2687) was granted to PanAmSat LC after the Transfer Application was filed -- on March 3, 2006.<sup>3</sup> It is respectfully requested, therefore, that the FCC take the new license into account in its processing of the Transfer Application. In addition, Intelsat is simultaneously filing an informational Form 312 application, which is not subject to public notice, to transfer control of the Galaxy 16 license from PanAmSat LC to Intelsat.
