**PLEADING CYCLE ESTABLISHED FOR PETITION OF CORE COMMUNICATIONS, INC.
FOR FORBEARANCE FROM SECTIONS 251(g) AND 254(g) OF THE COMMUNICATIONS
ACT AND IMPLEMENTING RULES**

By this Public Notice, we seek comment on a petition filed April 27, 2006 by Core Communications, Inc. ("Core") asking the Commission to forbear pursuant to section 160(c) of the Communications Act, as amended, from rate regulation preserved by section 251(g) of the Act and related implementing rules.¹ Specifically, Core requests that the Commission forbear from (i) section 251(g) and its implementing rules "to the extent they apply to or regulate the rate for compensation for switched 'exchange access, information access, and exchange services for such access to interexchange carriers and information service providers' pursuant to state and federal access charge rules" and (ii) "any limitation, by [Commission] rule or otherwise, on the scope of section 251(b)(5) that is implied from section 251(g) preserving receipt of switched access charges."² In addition, Core asks the Commission to forbear from the rate averaging and integration requirements contained in section 254(g) of the Act and its implementing rules.³ Core requests that the Commission apply the forbearance requested in its petition to all telecommunications carriers such that grant of its petition would subject these carriers to section 251(b)(5) of the Act for rate setting purposes.⁴

Interested parties may file comments on or before **June 5, 2006**, and reply comments on or before **June 26, 2006**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁵ Comments filed through the ECFS can be sent as an electronic file via

the Internet to <http://www.fcc.gov/cgb/ecfs/>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of the proceeding, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number, in this case, **WC Docket No. 06-100**. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to ecfs@fcc.gov, and should include the following words in the body of the message, "get form." A sample form and directions will be sent in reply. Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number.

Paper filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). **Parties are strongly encouraged to file comments electronically using the Commission's ECFS.**

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the

Commission's *ex parte* rules.⁶ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented generally is required.⁷ Other requirements pertaining to oral and written presentations are set forth in section 1.1206(b) of the Commission's rules.⁸
