COMMENTS

Waukomis Communications, by counsel, and pursuant to Sections 1.420 and 1.41 of the Commission's rules, 47 C.F.R. §§1.420 and 1.41, hereby submits its comments in support of the *Notice of Proposed Rule Making*, DA 06-433 (released February 24, 2006) ("*NPRM*"), proposing the allotment of Channel 292A at Waukomis, Oklahoma, in the above-captioned proceeding. In support of this request, the following is stated:

As noted in the *NPRM*, the allotment of Channel 292A at Waukomis would provide that community with its first local aural service. Channel 292A can be allotted to Waukomis in compliance with the Commission's minimum distance separation requirements with a site restriction of only 6.3 kilometers (3.9 miles) southwest of the community. Waukomis Communications believes that the proposed allotment of Channel 292A at Waukomis, Oklahoma, would serve the public interest.

If the Commission should adopt its proposal and allot Channel 292A at Waukomis, Waukomis Communications hereby states that it will apply for a construction permit for a new

FM station to operate on Channel 292A at Waukomis, Oklahoma, and, if its application is granted, will promptly construct and operate the new facility.

WHEREFORE, in light of the foregoing, Waukomis Communications respectfully requests that the Commission ADOPT the proposal set forth in the NPRM, AMEND the FM Table of Allotments, and ALLOT Channel 292A to Waukomis, Oklahoma, as that community's first local broadcast service.
