After thorough review and investigation of all relevant facts, the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (USAC) has made its decision in regard to your appeal of SLD's Funding Year 2005 Funding Commitment Decision Letter for the Application Number indicated above. This letter explains the basis of SLD's decision. The date of this letter begins the 60-day time period for appealing this decision to the Federal Communications Commission (FCC). If your Letter of Appeal included more than one Application Number, please note that you will receive a separate letter for each application.

Funding Request Number(s): 1296931
Decision on Appeal: **Denied**
Explanation:

- In your appeal letter, you state that the Anchorage School District is under contract with the State of Alaska to provide education services to students at the McLaughlin Youth Center. You attached copies of the FY06 Grant Award from the Alaska Department of Education and Early Development to Anchorage School District for the education of school aged youth at McLaughlin Youth Center and a copy of the Alaska state statute specifying continuing education of children who are held in detention facilities. You state that communications services at McLaughlin Secondary School, EIN 117179, that have been applied for under application 445730 are used exclusively by Anchorage School District staff and students. You reference a consultation with the State of Alaska E-Rate Coordinator, who is working with an assistant attorney general of Alaska in drafting a letter to USAC addressing the issue of schools within juvenile justice

facilities for all Alaska locations. You close by stating that the basic premise is that the juvenile justice facilities simply provide classrooms and the classrooms belong to the appropriate school district in that area.

- Upon review of the appeal letter and relevant supporting documentation, it was determined that McLaughlin Youth Center is a Juvenile Detention Center. Juvenile Detention Center facilities are not eligible in the state of Alaska. During the PIA review, you were asked to verify whether the McLaughlin Secondary School, entity#117179, was a Pre-K, Adult Education or Juvenile Justice Facility. You responded and said that McLaughlin is a Juvenile Justice Facility that contains an Anchorage School District secondary school. You also referenced websites to see more information on the Juvenile Justice Facility. Therefore, SLD supports PIA's initial decision.
- Whether an individual school, school district, or consortia of schools or school districts are eligible for discounts depends on whether the entity meets the statutory definitions as outlined above. The information provided indicates that this entity does not satisfy the definition(s) explained above, therefore, SLD denies your appeal because the entity(ies) is(are) not eligible for support.
- Your Form 471 application included costs for the following ineligible entity to receive services: McLaughlin Juvenile Justice Center. FCC rules provide that “[o]nly schools meeting the statutory definitions of “elementary school,” as defined in 20 U.S.C. 7801(18), or “secondary school,” as defined in 20 U.S.C. 7801(38) . . . shall be eligible for discounts.” 47 C.F.R. § 54.501(b)(1). The FCC has defined a “school” as including “individual schools, school districts, and consortia of schools and/or school districts.” Federal-State Joint Board on Universal Service, CC Docket No. 96-45, *Report and Order*, 12 FCC Rcd 8776, FCC 97-157, ¶ 425, n.1087 (rel. May 8, 1997). 20 U.S.C. 7801(18) defines an elementary school as “a nonprofit institutional day or residential school, including a public elementary charter school, that provides elementary education, as determined under State law.” 20 U.S.C. 7801(38) defines a secondary school as “a nonprofit institutional day or residential school, including a public secondary charter school, that provides secondary education, as determined under State law, except that such term does not include any education beyond grade 12.” 47 C.F.R. § 54.500(c), (k).

If your appeal has been approved, but funding has been reduced or denied, you may appeal these decisions to either the SLD or the FCC. For appeals that have been denied in full, partially approved, dismissed, or canceled, you may file an appeal with the FCC. You should refer to CC Docket No. 02-6 on the first page of your appeal to the FCC. Your appeal must be received or postmarked within 60 days of the date on this letter. Failure to meet this requirement will result in automatic dismissal of your appeal. Sec. 14.07.020. Duties of the department.

(a) The department shall

(1) exercise general supervision over the public schools of the state except the University of Alaska;

(2) study the conditions and needs of the public schools of the state, adopt or recommend plans, administer and evaluate grants to improve school performance awarded under AS 14.03.125, and adopt regulations for the improvement of the public schools;

(3) provide advisory and consultative services to all public school governing bodies and personnel;

(4) prescribe by regulation (a) minimum course of study for the public schools; the regulations must provide that, if (a) course in American Sign Language is given, the course shall be given credit as (a) course in (a) foreign language;

(5) establish, in coordination with the Department of Health and Social Services, (a) program for the continuing education of children who are held in detention facilities in the state during the period of detention;

(6) accredit those public schools that meet accreditation standards prescribed by regulation by the department; these regulations shall be adopted by the department and presented to the legislature during the first 10 days of any regular session, and become effective 45 days after presentation or at the end of the session, whichever is earlier, unless disapproved by (a) resolution concurred in by (a) majority of the members of each house;

(7) prescribe by regulation, after consultation with the state fire marshal and the state sanitarian, standards that will assure healthful and safe conditions in the public and private schools of the state, including (a) requirement of physical examinations and immunizations in pre-elementary schools; the standards for private schools may not be more stringent than those for public schools;


(8) exercise general supervision over pre-elementary schools that receive direct state or federal funding;

(9) exercise general supervision over elementary and secondary correspondence study programs offered by municipal school districts or regional educational attendance areas; the department may also offer and make available to any Alaskan through (a) centralized office (a) correspondence study program;

(10) accredit private schools that request accreditation and that meet accreditation standards prescribed by regulation by the department; nothing in this paragraph authorizes the department to require religious or other private schools to be licensed;

(11) review plans for construction of new public elementary and secondary schools and for additions to and major rehabilitation of existing public elementary and secondary schools and, in accordance with regulations adopted by the department, determine and approve the extent of eligibility for state aid of (a) school construction or major maintenance project; for the purposes of this paragraph, "plans" include educational specifications, schematic designs, and final contract documents;
