

In that capacity, I am writing to express our County's support of the expedited consideration and approval of the applications currently pending before the Federal Communications Commission for the sale of Adelphia Communications to the partnership of Comcast and Time Warner. This will allow for the completion of the transfer of our local franchise to Comcast, which our County Commission has already approved.

For nearly four years, cable service in our community has been tainted by uncertainty because of Adelphia's bankruptcy. From our review of the main points of the agreement and the financial standing and experience of Comcast, we believe that the agreement reached between Adelphia and the Comcast/Time Warner partnership is an acceptable method of transferring the Adelphia cable system assets in our community to a more financially secure entity.


