**MOTION FOR LEAVE TO SUPPLEMENT
COMMENTS AND COUNTERPROPOSAL**

Roy E. Henderson ("Henderson"), by his attorney, hereby respectfully requests leave to supplement his Comments and Counterproposal, timely filed in this proceeding, by the submission of the attached Memorandum of Law. In support thereof, it is alleged:

1. This proceeding is now uncontested. Charles Crawford, who initiated the proceeding, has withdrawn his expression of interest. Therefore, the only proposal presently pending is the Counterproposal submitted by Henderson.

2. Attached is a Memorandum of Law, dealing with the public interest benefits to be achieved, if Henderson's Counterproposal is adopted. Because this proceeding is now uncontested, consideration of the Memorandum of Law will not prejudice the rights of any other party to the proceeding. Furthermore, because the Memorandum is being submitted at a very early stage in the proceeding, it should not delay action by the Audio Division. On the other hand, consideration of the Memorandum will contribute to a fair and full record and will, therefore, serve the public interest.




