Subject: Resolution No. 54-26A11
Commending the Informational and Educational Broadcast Service provided by KALW(FM)
Commissioners Eric Mar, and Jill Wynns

WHEREAS: The San Francisco Unified School District (SFUSD) is an essential part of the San Francisco community, educating about 60,000 students annually and employing over 11,000 principals, teachers, educators, and administrative and staff members in more than 160 pre-school, elementary, middle, and high schools; and

WHEREAS: The SFUSD is governed by the Board of Education, which holds semimonthly meetings on the second and fourth Tuesdays of every month; and

WHEREAS: For many years, the Board of Education has relied on KALW(FM) to provide the San Francisco community with coverage of the Board of Education's actions and activities and other information related to the public schools; and

WHEREAS: In particular, during the periods from November 3, 1996 to November 3, 1997 and from July 16, 2003 to July 16, 2004, KALW(FM) (i) devoted significant amounts of air time to live "gavel-to-gavel" broadcasts of Board of Education meetings; (ii) regularly broadcast programs that addressed education issues in or affecting San Francisco's public schools, including "Making the Grade" and "Looking at Education;" and (iii) announced daily the school lunch menu with readings by an eclectic mix of local and national celebrities; and

WHEREAS: The Board of Education wishes to express appreciation to KALW(FM) for helping the Board of Education to advance its important mission to increase community awareness of educational issues.

THEREFORE BE IT RESOLVED: That the Board of Education commends KALW(FM) for its meritorious service to the community, including, specifically, its broadcast of Board of Education meetings and other programming related to the SFUSD; and

BE IT FURTHER RESOLVED: That the Board of Education is proud to recognize and honor the staff of KALW(FM) for the invaluable role they play in the informing the public of issues of importance to our city's public school students and their parents and teachers.
