Notification re Replication/Maximization Interference Protection Deadline**

Dear Ms. Dortch:

Agape Church, Inc. ("Agape") is the licensee of television satellite station KVTH, Hot Springs, Arkansas, which operates on NTSC channel 26 and has been assigned DTV channel 14. By letter dated February 9, 2005, Agape notified the FCC of its intention to "flash-cut" KVTH from analog to digital transmission on its channel 26 allotment by the end of the digital television transition period, and surrender its channel 14 DTV allotment. *See also* FCC File No. BFRECT- 20050208AEF. Pursuant to the Commission's *Report and Order*, FCC 04-192 at ¶104, MB Docket No. 03-15 (rel. Sept. 7, 2004), a satellite station that elects the "flash-cut" option will be treated as if it met the applicable replication/maximization build-out requirement. As a result, KVTH is not subject to the Commission's July 1, 2006 "use-or-lose" deadline.
