Dear Mr. Kelly:

I am writing to request that the EA Licensee Relocation Election previously filed on February 6, 2006, by Skitronics, LLC, ("Skitronics") herein be amended and modified in that Exhibit 1 of that election be amended and supplemented by adding thereto an omitted license, specifically WPVF847, a site based license located in EA #21 that was omitted from the original Exhibit 1 as a result of a clerical transcription error. Documentary evidence is attached that this omitted site-based license was an integral part of Skitronics' EA-based system as of November 22, 2004, as the site is located within the geographical boundaries of the relevant EAs.

This license is owned by Waccamaw Wireless, LLC. The EA licensee is Skitronics, LLC. Skitronics, LLC, is wholly owned by two private individuals who also control seventy five percent (75%) of the ownership interest of Waccamaw Wireless, LLC.

All facts set forth in the preceding paragraphs are supported by the attached declaration under penalty of perjury of John Komorowski, made in accordance with the requirements of Section 1.16 of the Commission's rules. (As Section 1.16 is explicitly intended to do away with the requirement of notarization, the Komorowski declaration is not notarized. However, it is authentic.)


