**MOTION FOR LEAVE TO SUPPLEMENT APPLICATION FOR REVIEW**

Meadowlark Group, Inc. ("MGI"), by its attorney, hereby respectfully requests leave to file the accompanying Supplement to its Application for Review (hereinafter, the "Supplement") in this proceeding. In support thereof, it is alleged:

1. This proceeding involves a rulemaking, initiated by Clear Channel, to move Station KTCL from Fort Collins, Colorado to Wheat Ridge, Colorado, operating on Channel 227C. MGI filed a counterproposal to allocate Channel 248C to Creede, Colorado, where the allotment would provide substantial service to white areas, where there is presently no reception service. The counterproposal was, however, denied; MGI filed a Petition for Reconsideration, which was also denied; and MGI filed an Application for Review, which remains pending.

2. New facts have now been discovered which show that the Wheat Ridge proposal should never have been adopted, in the first place. It was always short-spaced to an allotment at Leadville, Colorado and was, therefore, defective on the day when it was tendered.

3. These facts are set forth, in detail, in the accompanying Supplement. Acceptance of the Supplement will serve the public interest. It will contribute to a complete record. It will not prejudice the rights of any party to the proceeding because no party has a right to rely upon

defects in the Commission's database. *Office of Pers. Management v. Richmond*, 496 U.S. 414, 433 (U.S. 1990).


4. WHEREFORE, it is respectfully requested that the accompanying Supplement be accepted.


