Subsequent to the issuance of the Commission's recent Orders in the above referenced matters, TCR Sports Broadcasting Holding, L.L.P., and Comcast Corporation have engaged in extensive negotiations in an attempt to resolve the dispute related to Comcast's refusal to carry TCR's programming. I am happy to report that the parties have reached an agreement under which Comcast will begin carriage of TCR's programming within the Baltimore/Washington area immediately. Comcast has further agreed to carry TCR's programming within TCR's entire television territory by no later April 1, 2007.


Accordingly, TCR will not invoke the arbitration procedures set forth in Paragraph 190 and Appendix B of the Adelfia Order and will dismiss the carriage complaint proceeding. The parties will file a notice of dismissal shortly.
