Dear Ms. Dortch:

On behalf of Time Warner Inc., this is to notify the Commission that on July 31, 2006, the appropriate affiliates or subsidiaries of Time Warner Cable Inc. (collectively, "Time Warner Cable") have acquired the cable television systems and any associated Commission licenses and authorizations from affiliates or subsidiaries of Adelphia Communications Corporation and Comcast Corporation in accordance with the Commission's approval of these transactions on July 13, 2006. Further notification will be provided to the appropriate Commission Bureaus regarding the consummation of the assignments and/or transfers of control of individual licenses and authorizations.

Subsequent to the letter to Marlene H. Dortch dated July 12, 2006 from James R. Coltharp, Comcast Corp., Steven N. Teplitz, Time Warner Inc., and Michael H. Hammer, Willkie Farr & Gallagher, LLP, Counsel for Adelphia Communications Corp., approvals have been received from each of the LFAs listed in n. 890 of the FCC July 13th Order with respect to the cable systems designated for acquisition by Time Warner Cable. Such approvals include the grant of authority for Time Warner Cable to operate affected cable systems while negotiations continue relating to the exercise of rights of first refusal asserted by certain LFAs.


