SUPPLEMENT

CXR Holdings, L.L.C. ("CXR"), by its counsel, hereby submits its Supplement in the above captioned proceeding. The purpose of this Supplement is to inform the Commission that it no longer needs to issue an Order to Show Cause to Edinburgh Radio, licensee of Station WYGB(FM), Edinburgh, Indiana because CXR has entered into a reimbursement agreement with Edinburgh Radio and obtained its consent to the proposed channel change. In support hereof, CXR states as follows:


In its Counterproposal filed on May 30, 2006, CXR requested that the Commission issue an Order to Show Cause to Edinburgh Radio to show why Station WYGB(FM)'s channel should not be changed from Channel 275A to 262A at the Station's current site. This change was necessary in order to permit changes to Station WXCH(FM), Versailles, Indiana. Following the

filing of CXR's Counterproposal, CXR and Edinburgh Radio negotiated a reimbursement agreement and Edinburgh Radio's consent statement is attached hereto, whereby Edinburgh Radio states that it agrees to change the channel of Station WYGB(FM) from Channel 275A to 262A to accommodate CXR's proposal. Thus, an Order to Show Cause is no longer necessary.


