Dear Ms. Dortch:

In accordance with the Order adopting the Protective Order, the Order adopting the Second Protective Order, and the instructions we have received from the Staff of the Wireline Competition Bureau ("WCB"), enclosed please find a CD-ROM containing revised responses to Specifications 47(1), 47(2), and 49 of the Federal Communications Commission's ("FCC" or "Commission") Initial Information and Document Request of June 23, 2006. After discussions with the International Bureau staff, these revised responses more appropriately reflect the minutes and revenues associated with BellSouth's international traffic in the manner requested by the International Bureau. Specifically, the responses have been revised to: (i) reflect U.S. Billed Facilities Based Service and International Resale Services only in response to Specifications 47.1 and 47.2, respectively; (ii) include Cingular international traffic; and (iii) exclude terminations to Puerto Rico. By this letter, BellSouth submits the requested amended Exhibits.

Per the direction of the Staff, BellSouth is filing today, under separate transmittal, (2) paper copies of the unredacted Exhibits and two (2) CD-ROMs containing unredacted copies of these Exhibits with Gary Remondino of the Wireline Competition Bureau.
