



This includes High Cost Loop support, Local Switching Support, High Cost Model support, Hold Harmless support, and high cost support received pursuant to the purchase of exchanges.

Attached is the list of rural carriers certified by the New Hampshire Public Utilities Commission pursuant to sections 54.313 and 54.314 of the FCC's rules (47 C.F.R. § 54.313, 54.314), which require states to establish an annual certification process for rural and non-rural carriers receiving federal high cost support. 
