Re: Request for Information Concerning Applications for Consent to the Transfer of Control of Licenses and Authorizations Held by Guam Cellular and Paging, Inc., and to the Assignment of License Held by Guam Wireless Telephone Company, LLC, to NTT DoCoMo, Inc., and Petition for Declaratory Ruling, WT Docket No. 06-96 (File Nos. 0002556700 and 0002553437)¹

Dear Mr. Mosley and Mr. Patrich:

On April 11, 2006, the Commission received the above-captioned applications filed pursuant to sections 214 and 310(d) of the Communications Act of 1934, as amended (the "Act"), and a petition for declaratory ruling on foreign ownership under section 310(b)(4) of the Act.² In order for the Commission to complete its review of the applications and make the necessary public interest findings under section 310(d) of the Act, we require data from other commercial wireless carriers against which the applicants compete.

Accordingly, pursuant to sections 4(i), 4(j), and 403 of the Act,³ we request that you provide written data as set forth in the Attachment. Your response will be treated as confidential

pursuant to the Protective Order issued in WT Docket No. 06-96, on September 15, 2006.⁴ We would appreciate receiving your response no later than September 29, 2006.

Your response should be hand delivered to Erin McGrath, Weiren Wang, or Nina Shafran of the Wireless Telecommunications Bureau (the "Bureau") and marked "Confidential Information – Subject to Protective Order in WT Docket No. 06-96 before the Federal Communications Commission." A cover letter indicating the delivery of your response must be filed with Marlene H. Dortch, Secretary, Federal Communications Commission, referencing WT Docket 06-96. The Protective Order and the Public Notice require the submission of multiple copies of the filing.⁵ If you file the cover letter electronically using the Commission's Electronic Comment Filing System ("ECFS"), you should also send a copy of the letter via e-mail to Erin McGrath, erin.mcgrath@fcc.gov, Weiren Wang, weiren.wang@fcc.gov, and Nina Shafran, nina.shafran@fcc.gov.

2. Please provide coverage maps for a -95 dBm signal level or better for your company's mobile wireless services in each of (1) Guam, and (2) CNMI (in particular, the three main islands). Maps should be submitted in a geo-referenced format, such as a shapefile (for ArcMap) or table (for Mapinfo).
