DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF THE ASSETS OF NORTH DAKOTA TELEPHONE COMPANY TO SRT COMMUNICATIONS, INC.

NON-STREAMLINED PLEADING CYCLE ESTABLISHED

On October 2, 2006, SRT Communications, Inc. ("SRT") and North Dakota Telephone Company ("NDTC") (jointly, the "Applicants") filed an application pursuant to section 63.04 of the Commission's rules¹ requesting approval for the transfer of control of certain assets in the Velva exchange in North Dakota from NDTC to SRT. The Applicants did not request streamlined treatment for this application pursuant to section 63.03 of the Commission's rules.²

NDTC, a North Dakota corporation, provides landline telecommunications services in rural counties of North Dakota. NDTC is based in Devil's Lake, North Dakota and is owned by three North Dakota based telephone cooperatives: (1) United Telephone Mutual Aid Corporation (40.5%), based in Langdon, North Dakota; (2) Dakota Central Rural Telephone Cooperative (19%), based in Carrington, North Dakota; and (3) Polar Communications Cooperative (40.5%), based in Park River, North Dakota. Each of the three owners of NDTC is a cooperative that is owned by its respective members, none of whom owns as much as a one percent (1%) interest in the company. NDTC acquired the Velva exchange on June 1, 1996, which is located in McHenry County, North Dakota. As of June 30, 2006, NDTC provided service to 720 access lines in the Velva exchange.

SRT, a North Dakota cooperative corporation, has been a provider of telecommunications services within the state of North Dakota since 1951 and is subject to regulation and general supervision by the Public Service Commission of North Dakota. SRT is owned by its members, none of whom owns as much as a one percent (1%) interest in the company. SRT serves 26 rural exchanges in north

central North Dakota and as of June 30, 2006, provided service to 37,696 access lines.

SRT and NDTC have entered into a Purchase and Sale Agreement for SRT's purchase of NDTC's assets of the Velva exchange relating to provision of local exchange telecommunications service, exchange access and other local telecommunications service.³ The exchange consists of buried facilities, above ground facilities, and the right to serve customers, of which there are now approximately 720, in and near the city of Velva, North Dakota.

The Applicants state that the proposed transaction will serve the public interest because the Velva exchange is surrounded by SRT's existing landline exchanges. Customers in the Velva exchange will be able to call the Minot community toll free under SRT's Extended Area Service Plan. Minot is the economic hub city for the community of Velva. In addition, SRT already serves Velva exchange customers with wireless telephone services and cable television services. Velva exchange customers will now be able to obtain both landline and wireless services from one provider.

GENERAL INFORMATION

The transfer of assets identified herein has been found, upon initial review, to be acceptable for filing as a non-streamlined application. The Commission reserves the right to return any transfer of assets application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file comments **on or before October 20, 2006** and reply comments **on or before October 27, 2006**.⁴ Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

SRT will make available to customers of the Velva exchange, as one of their options for interexchange services, the services of SRT Long Distance, which is an affiliate of SRT. No customers of the Velva exchange will be obligated to make any change in their selection of interstate or international service provider following the sale of the Velva assets of NDTC to SRT.
