## DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF NATIONAL COMTEL NETWORK, INC. TO TODD MCINTYRE

### STREAMLINED PLEADING CYCLE ESTABLISHED

Comments Due: October 19, 2006

Reply Comments Due: October 26, 2006

On September 08, 2006, National ComTel Network, Inc. ("NCN") and Todd McIntyre ("Mr. McIntyre") (collectively, "Applicants"), filed an application, pursuant to section 63.04 of the Commission's rules,<sup>1</sup> requesting authority to transfer control of NCN to Mr. McIntyre.<sup>2</sup>

Applicants assert that this transaction is entitled to presumptive streamlined treatment under 63.03(b)(2)(i) of the Commission's rules because, upon completion of the proposed transaction: (i) Transferee will have a market share in the interstate, interexchange market of less than 10 percent; (ii) Transferee will provide competitive telephone exchange or exchange access services, if at all, exclusively in geographic areas served by a dominant local exchange carrier that is not a party to the transaction; and (iii) none of the Applicants or their affiliates are dominant with respect to any service.<sup>3</sup>

NCN, a California corporation, is a non-dominant interexchange and competitive local exchange carrier providing intrastate, interstate, and international telephone service to business customers. Jeff Foss, a U.S. citizen, has 100% equity interest in NCN.

Mr. McIntyre, a U.S. citizen, currently is a manager of NCN. Mr. McIntyre has no other equity interest in a telecommunications carrier.

Pursuant to a stock purchase agreement entered into on June 30, 2006, Mr. McIntyre will acquire 100% of the issued and outstanding shares of stock in NCN. NCN will continue providing service to its customers, without change, and in accordance with all of its existing tariffs and contracts.

Applicants state that the proposed transaction will serve the public interest because it will be completely transparent to customers of NCN and will ensure that NCN continues to provide a full range of affordable and high quality interstate and international telecommunications services.

## **GENERAL INFORMATION**

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file **comments on or before October 19, 2006** and **reply comments on or before October 26, 2006.**<sup>4</sup> Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets and related control on the 31<sup>st</sup> day after the date of this notice.<sup>5</sup> Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
