OFFICE OF ENGINEERING AND TECHNOLOGY DECLARES THE ULTRAVISION SECURITY SYSTEMS, INC. REQUEST FOR A WAIVER OF PART 15 TO BE A "PERMIT-BUT-DISCLOSE" PROCEEDING FOR *EX PARTE* PURPOSES AND REQUESTS COMMENTS

On October 6, 2006, UltraVision Security Systems, Inc. ("UltraVision") filed a request for a waiver of Part 15 of the Commission's rules to permit the marketing and operation of an ultra-wideband ("UWB") surveillance system that operates below 700 MHz. UltraVision's system would be used in fixed locations to track the location, velocity and mass of an intruder. It can be programmed to respond only to pedestrians or vehicles or only to vehicles operating above a certain size or speed.

The UltraVision surveillance system complies with all of the emission limits specified in Section 15.511 of the regulations. However, it does not operate within the 1990-10600 MHz band as required under Section 15.511(a). UltraVision also requests that the categories of parties eligible to operate UWB surveillance systems, as specified in Section 15.511(b), be expanded to permit operation by any entity eligible for licensing under the Part 90 regulations.

In order to develop a complete record on the complex issues presented by this request, this proceeding will be treated, for *ex parte* purposes, as a "permit-but-disclose" proceeding, in accordance with Section 1.1200(a) of the Commission's rules, and is subject to the requirements under Section 1.1206(b) of the rules.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file comments and reply comments on or before **November 24, 2006**, and reply comments on or before **December 8, 2006**. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
