**OFFICE OF ENGINEERING AND TECHNOLOGY DECLARES A PETITION FOR
WAIVER OF THE PART 15 DIGITAL TV RECEPTION REQUIREMENT FROM
SUMITOMO CANADA LIMITED TO BE A "PERMIT-BUT-DISCLOSE"
PROCEEDING FOR *EX PARTE* PURPOSES AND REQUESTS COMMENTS**

On September 8, 2006, Sumitomo Canada Limited (Sumitomo) filed a Petition for Waiver of Part 15 of the Commission's rules requesting a 12-month extension of the March 1, 2007 deadline for compliance with the requirement that new broadcast television receivers include the capability to receive digital television signals. The TV receivers for which Sumitomo requests this extension are part of a specialized video system designed for healthcare facilities. In requesting this extension, Sumitomo states that applying the March 1, 2007 date to its products would impede its ability to deliver these specialized systems to the healthcare market and thereby affect the quality of the healthcare experience for many patients.

The FCC's Office of Engineering and Technology ("OET") is reviewing the waiver request. OET has concluded that in order to develop a complete record on the issues presented by this request, this proceeding will be treated, for *ex parte* purposes, as a "permit-but-disclose" proceeding, in accordance with Section 1.1200(a) of the Commission's rules, and is subject to the requirements under Section 1.1206(b) of the rules.

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file comments and reply comments on or before the dates indicated on the first page of this document. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/> or the Federal eRulemaking Portal: <http://www.regulations.gov>. Filers should follow the instructions provided on the website for submitting comments.
 - For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail).
