JOINT APPLICATION

I. INTRODUCTION

A. Summary of Transaction

RCN Telecom Services, Inc. ("RCN") and Astound Broadband, LLC ("Astound") (together "Applicants"), through undersigned counsel and pursuant to Section 214 of the Communications Act, as amended, 47 U.S.C. § 214, and Sections 63.04 and 63.24 of the Commission's Rules, 47 C.F.R. §§ 63.04, 63.24, respectfully request Commission approval or such authority as may be necessary or required to complete a transaction whereby Astound will acquire from RCN certain assets in the State of California, including certain customer accounts. Astound currently holds international Section 214 authority as granted in File No. ITC-ASG-

20050701-00241.¹ As described below, because the rates, terms or conditions of the services being received by customers will not change as a result of the transfer, other than seeing a change in the identity of the carrier the proposed transaction will be virtually transparent to customers of RCN in terms of the services that those customers receive.

Applicants file this Application in connection with an Asset Purchase Agreement (“Agreement”) dated August 17, 2006. Through the Agreement, RCN has agreed to sell to Astound certain California telecommunications assets, including its customer base, networks, and telecommunications switch in Northern California.² As a result of the transaction, RCN’s current Northern California customers will be transferred to Astound, which will become the service provider for those customers.

B. Request for Streamlined Processing

Applicants respectfully submit that this Application is eligible for streamlined processing pursuant to Section 63.03 and 63.12 of the Commission's Rules, 47 C.F.R. §§ 63.03 & 63.12.

With respect to domestic authority, this Application is eligible for streamlined processing pursuant to Section 63.03(b)(2)(i) because, immediately following the transaction, (1) Applicants and their affiliates, as defined in Section 3(1) of the Communications Act (“Affiliates”) combined will hold less than a ten percent (10%) share of the interstate, interexchange market; (2) Applicants and their Affiliates will provide local exchange service only in areas served by dominant local exchange carriers (none of which is a party to the proposed transaction) and; (3)

¹ RCN will continue to provide domestic interstate and international telecommunications services in Southern California and its markets outside of California, and therefore is not assigning its Section 214 authorizations to Astound.

² In addition to the telecommunications assets described herein, RCN has also agreed to sell its cable television and open video system operations in Northern California to Astound.

none of the Applicants or their Affiliates is dominant with respect to any service that they provide.

With respect to international authority, this Application is eligible for streamlined processing pursuant to Section 63.12(a)-(b) of the Commission's Rules, 47 C.F.R. §63.12(a)-(b), since none of the exceptions set forth in Section 63.12(c) apply. In particular, Section 63.12(c)(1) is inapplicable because none of the Applicants is a foreign carrier, or is affiliated with any foreign carriers. Furthermore, none of the scenarios outlined in Section 63.12(c)(2)-(4) apply to the Applicants.

In support of this Application, Applicants provide the following information:

II. DESCRIPTION OF THE APPLICANTS

A. RCN Telecom Services, Inc. (Assignor)

RCN is a corporation organized and existing under the laws of the Commonwealth of Pennsylvania with principal offices located at 196 Van Buren St., Ste. 300, Herndon, VA 20170. RCN is a wholly-owned subsidiary of RCN Corporation, a publicly-traded Delaware corporation. RCN and certain of its affiliates provide video, data and voice services in the Boston, New York, Philadelphia/Lehigh Valley, Chicago, Los Angeles, San Francisco, and Washington, D.C. metropolitan markets.³ RCN holds blanket domestic Section 214 authority and international Section 214 authority to provide global facilities-based and global resale service. RCN is also authorized to provide local exchange and intrastate interexchange telecommunications services in California and is making the necessary filings to the California Public Utilities Commission to assign those operations to Astound.

³ RCN affiliates that provide competitive telecommunications services outside of California include: RCN Telecom Services of Illinois, LLC, RCN Telecom Services of Washington, D.C., Inc., RCN Telecom Services of Massachusetts, Inc., RCN Telecom Services of Philadelphia, Inc., RCN-BecoCom, Inc., RCN Communications of New York, LLP, and Starpower Communications, LLC.

B. ASTOUND BROADBAND, LLC (Assignee)

Astound is a direct, wholly owned subsidiary of WaveDivision Holdings, Inc. (“Wave”), a Delaware limited liability company formed in 2002. Astound, a Washington limited liability company, was formed by Wave in 2005 in connection with its acquisition of certain California cable and telecommunications assets of Seren Innovations, Inc. See FCC Docket No. WC-05-226. Together, Wave and Astound currently serve approximately 155,000 cable television, high-speed data and telephone customers in western Washington and California. Astound holds blanket domestic Section 214 authority and international Section 214 authority to provide global resale service. See FCC Public Notice, DA-05-2440, Docket No. WC-05-226 (Sept. 12, 2005); FCC Public Notice (Erratum), Docket No. 05-226 (Sept. 22, 2005) and FCC Public Notice DA-05-2397 (Sept. 1, 2005), ITC-ASG-20050701-0024.

III. DESCRIPTION OF THE TRANSACTION

Applicants propose to complete a transaction (“Transaction”) through which Astound will acquire certain assets of RCN, including its customer base in Northern California, pursuant to an Asset Purchase Agreement (“Agreement”) dated August 17, 2006. Specifically, Exhibit A provides a list of the communities where RCN assets are being transferred to Astound (the “Affected Service Area”). The specific assets to be acquired by Astound include the customer accounts associated with RCN’s domestic interstate and international telephone service in the Affected Service Area. The Transaction does not affect RCN’s operations outside of the Affected Service Area.

Upon the transfer of the customers and related assets, Astound will provide service to these customers under comparable rates, terms and conditions as currently being provided by RCN. As a result, other than seeing a change in the identity of the serving carrier, the proposed Transaction will be virtually transparent to customers served by RCN in terms of the telephone

services that they currently receive. All of the affected customers will receive notice in compliance with the Commission's Rules.⁴

IV. PUBLIC INTEREST STATEMENT

Applicants respectfully submit that the proposed transaction serves the public interest. The Transaction is expected to invigorate competition in Northern California. Through the Transaction, Astound will expand its customer base, which will give Astound a greater presence in the telecommunications market in California, and thereby make Astound a more viable competitor in all of its markets. Moreover, RCN's business has been primarily focused on the Boston-to-Washington northeast corridor and Chicago and its operations in California have not been of sufficient scope and scale to be able to become an effective competitor in the marketplace. Astound and Wave, on the other hand, are focusing their operations on markets on the West Coast, and as a result, they will be better positioned to provide meaningful competition in the Affected Service Area.

The Transaction will not adversely impact existing RCN customers. The proposed transaction is structured to assure an orderly transition of the affected customers from RCN to Astound. Moreover, given that Astound proposes to provide service on comparable rates, terms and conditions of the services that RCN currently provides, Applicants expect the transaction to be virtually transparent to the customers in terms of the service they receive. RCN's customers in the Affected Service Area will be properly notified of the Transaction and the change in their telecommunications provider from RCN to Astound, and be fully informed of their options.


