COMMENT SOUGHT ON REQUEST FOR DECLARATORY RULINGS

This Public Notice invites comment on the Request for Declaratory Rulings filed by One Stop Financial, Inc., Group Discounts, Inc., 800 Discounts, Inc., and Winback & Conserve Program, Inc.¹ The Request for Declaratory Rulings was filed pursuant to order of the United States District Court for the District of New Jersey.² Specifically, the district court ordered that plaintiffs in the matter *Combined Companies, Inc. and Winback & Conserve Program, Inc., One Stop Financial, Inc., Group Discounts, Inc. and 800 Discounts, Inc. v. AT&T Corp.*, Civ. No. 95-908 (WGB), file with the Commission to initiate an administrative proceeding to resolve the issues under section 2.1.8 of AT&T's Tariff No. 2 as well as any other issues left open by the D.C. Circuit's Opinion in *AT&T Corp. v. FCC*, 394 F.3d 933 (D.C. Cir. 2005).³

Interested parties may file comments on or before **December 20, 2006**, and reply comments on or before **January 17, 2007**. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies.⁴

- For ECFS filers, commenters should transmit one electronic copy of the comments to WC Docket No. 06-210 (under "Proceeding"). In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and CCB/CPD 96-20 (under "File Number"). Parties may also submit an electronic comment by Internet e-mail. To get filing instructions, filers should send an e-mail to ecfs@fcc.gov, and include the following words in the subject line or body of the message: get form <your email address>. A sample form and directions will be sent in response.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules.⁵ Persons making oral *ex parte* presentations are reminded that memoranda *summarizing presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed.* More than a one or two sentence description of the views and arguments presented generally is required.⁶ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission’s rules.⁷
