On September 5, 2006 the Commission, by its Assistant Chief, Audio Division, Media Bureau, released a Report and Order in the above-referenced proceedings, which, *inter alia*, dismissed the Petition for Rule Making (treated as a counter proposal in MB Docket No. 05-10) filed by Portland Broadcasting, LLC, Columbia Gorge Broadcasters, Inc., M.S.W. Communications, LLC and Extra Mile Media, Inc. (the "Joint Petitioners"). The Joint Petitioners filed a Petition for Reconsideration of the Commission action on October 27, 2006. Under the Commission's rules, Oppositions to Petitions for Reconsideration are due to be filed

within fifteen (15) days of the date of Public Notice of the Petition for Reconsideration in the Federal Register and Replies to an Opposition and due to be filed within ten (10) days after the time for filing Oppositions has expired. See Section 1.4 (b) (1) of the Commission's rules and attached Public Notice, Report No. 2800, released December 8, 2006.

Public Notice of the Joint Petitioners' Petition for Reconsideration has not yet occurred in the Federal Register. Cumulus Licensing, LLC ("Cumulus") has filed an Opposition to that Petition for Reconsideration. However, the date of Joint Petitioners' Reply is measured from the date that Public Notice of the Petition for Reconsideration is given in the Federal Register, not the date of the Cumulus filing. Since the Petition for Reconsideration has not yet been published, the filing due date for Joint Petitioners' Reply to the Cumulus Opposition as well as other comments which are filed has not yet been set. Joint Petitioners intend to file a Reply at the appropriate time under the Commission's rules.
