

**Text of E-mail from Doug Livingston, Patriot Communications to Reese Butler, Kristin Brooks Hope Center:**

Reese...

The definition of a subscriber is the end user who pays for the usage generated by the toll-free telephone number. Therefore, Patriot Communications is the current subscriber of the toll-free telephone numbers in question, since Patriot has paid for the usage generated by the toll-free telephone numbers. KBHC has not paid for the usage. Furthermore, I don't understand what you mean by stating that you continue to be willing to pay your debt to Patriot. You were contracted to do so for the services we provided.

As I have stated before, if we receive payment from KBHC for \$67,897.84, as well as payment from SAMHSA for whatever balance they owe since August 25, 2006, we will release the toll-free telephone numbers. At this point, I really don't care to whom we release the numbers.

Reese, I have been extremely accommodating to all of the parties, even though we've not been paid, we've incurred legal fees, and I personally have been harassed and threatened by KBHC supporters at my office and home.

Patriot suggests Kristin Brooks Hope Center ("KBHC") submit a change of Resporg request for the balance of the toll-free telephone numbers listed above, so that another service provider may support them. Alternatively, Patriot will release those toll-free telephone numbers back to the toll-free telephone number administrator.

Patriot is ready, willing and able to continue to support the other three (3) toll-free telephone numbers. We understand that KBHC contends that Patriot cannot support those toll-free telephone numbers. Patriot disagrees with that contention. The relative merits of the parties' positions should not be their focus at this time.

Fortunately, all stake holders share a common goal of ensuring that these toll-free telephone numbers continue to be supported so that a vital public service is available to persons in crisis. Indeed, KBHC stated on or around August 25, 2006 that it would donate 1 (800) SUICIDE ((800) 784-2433) to SAMHSA at no cost.

While Patriot would be pleased to continue to support the suicide-prevention toll-free telephone numbers, it is not willing to do so unless SAMHSA and KBHC confirm in a binding, written agreement that Patriot may do so and that KBHC will assert no claims against Patriot for having done so or continuing to do so. Absent an agreement in writing from KBHC and SAMHSA by January 8, 2007, acknowledging Patriot may continue to support these toll-free telephone numbers, and that no claims will be made

for Patriot's doing so or having done so in the past, Patriot will cease routing telephone calls to the toll-free telephone numbers at 12:01 am on January 9, 2007 and will post an outgoing message directing callers to call 1-800-273-TALK for assistance.

Patriot is committed, given the current conditions, to supporting the toll-free telephone numbers through the critical holiday season. Patriot trusts and anticipates that before January 8, 2007, one or more written agreements and releases among SAMHSA or its designee, Patriot and KBHC will be executed. We remain hopeful that no interruption in services will be required, but wanted to express Patriot's position clearly, and early, so that all interested parties may plan accordingly.

We look forward to hearing that SAMHSA and KBHC have agreed that Patriot may continue to support these important toll-free telephone numbers so that such an agreement may be documented in a timely manner.



Re: Request to cease and desist illegal transfer of toll-free numbers

Dear Gentlemen:

I am writing on behalf of my client, the Kristin Brooks Hope Center ("KBHC"), in response to apparent misunderstandings of the law on the part of Patriot Communications LLC ("PatriotNet"), McLeodUSA Telecommunications Services ("McLeod"), and the Substance Abuse and Mental Health Services Administration ("SAMHSA"). Specifically, KBHC has for many years been the subscriber of record to and had the legal right to use several toll-free numbers, including 800-SUICIDE. All of these numbers are used as part of KBHC's non-profit suicide prevention activities. It is my understanding that PatriotNet is seeking to commandeer one or more of these numbers as its own and transfer the number(s) to another end user - SAMHSA or its grantee, Link2Health Solutions Inc. I further understand that McLeod, as the Resp Org for these numbers, is cooperating in this illegal activity by refusing to allow KBHC to move its toll free numbers to another Resp Org. This refusal to transfer toll-free numbers is in violation of FCC rules, telephone company tariffs, and the terms of McLeod's Resp Org authorization. Further, PatriotNet's claim to any control over the numbers is in error and would represent an unlawful transfer of the toll free numbers from one user (KBHC) to another (PatriotNet). Moreover, any public use of the 800-SUICIDE trademark held by KBHC will

result in an infringement of that mark as well.<sup>1</sup> This letter puts all parties on notice of these facts, making any future violations knowing and willful.

Telephone number assignments, including toll-free numbers, are governed by the Federal Communications Commission and its designee, the North American Numbering Plan Administrator (currently Neustar, Inc.).<sup>2</sup> Toll-free numbers may only be assigned and transferred in accordance with the rules and regulations promulgated by the FCC and NANPA. These rules are found at 47 C.F.R. § 52.101 et. seq., the tariff is SMS/800 Functions Tariff F.C.C. No. 1 (“SMS/800 Tariff”), and the accompanying industry guidelines may be found at ATIS/OBF-TFG-013, Issue 13 (July 2003)(“Toll Free Guidelines”).

A review of these regulations makes clear that: (1) “no individual or entity ... has a proprietary interest in any given toll free number; however, subscribers do have a controlling interest in their active numbers”;<sup>3</sup> (2) numbers may not be transferred from one end user to another, but instead must be returned to the numbering pool for a quiet period and then are available on a first come, first served basis;<sup>4</sup> (3) carriers may not seize control of toll-free numbers or transfer them to other users as a means of bill collection;<sup>5</sup> and (4) Resp Orgs are obligated to respect the requests of subscribers or their agents when transfers are sought.<sup>6</sup> Resp Orgs and carriers are expected to have knowledge of these rules and requirements as part of their continuing authorization to operate as such.



However, in an e-mail exchange with KBHC, PatriotNet has asserted that it has become the "subscriber" because KBHC has outstanding invoices – this is flatly wrong and suggests an unlawful transfer of a toll-free number;<sup>7</sup> PatriotNet's further proposal to transfer the number to another end user – SAMHSA – is also unlawful for the same reasons, as well as violating the prohibition against transferring numbers for profit. KBHC has recently submitted a Resp Org change form to McLeod to move two of its toll free numbers to a different Resp Org. The rejection of those requests is a violation of McLeod's duty as a Resp Org to release an 800 subscriber's SMS/800 record numbers upon request.<sup>8</sup>

By this letter we ask that McLeod cease and desist its unlawful refusals to transfer the numbers to another Resp Org. We further ask that PatriotNet cease and desist its unlawful claims to be the subscriber of any of KBHC's toll free numbers. Failure to give prompt agreement to these requests will force KBHC to move this matter to the Federal Communications Commission or the courts for resolution and injunctive relief. In view of the clear and blatant rule violations that have been already been threatened verbally and in e-mails, we believe the better approach for all concerned is to honor KBHC's Resp Org transfer requests and its right to control its own toll free numbers.

Re: Refusal to transfer toll-free numbers to the RespOrg of the user's choice

Dear Mr. Haas:

On October 23, 2006, I wrote to you concerning the refusal of McLeodUSA to honor a request from the Kristin Brooks Hope Center for the transfer of certain toll-free numbers from McLeodUSA to a different RespOrg. I am writing you today because McLeodUSA personnel again are engaging in the same unlawful conduct.

As you may recall, KBHC is a non-profit suicide prevention organization that operates several toll-free numbers to further its mission. The carrier for these numbers is Patriot Communications and the RespOrg is McLeodUSA. Prior to my October 23 letter, McLeodUSA personnel were refusing to honor RespOrg transfer requests made by KBHC pursuant to instructions from PatriotNet. Following my letter's explanation of the law in this area – specifically that KBHC is the customer of record for the toll-free numbers and, as such, has complete and total discretion to choose its RespOrg – McLeodUSA honored KBHC's request to move two of its toll-free numbers to a different RespOrg.

In recent days, however, KBHC's agent made a request to transfer its remaining toll-free numbers to a new RespOrg. This request was refused on an absurdly thinly veiled rationale - that KBHC had incorrectly spelled its own name. In fact, the spelling was exactly the same as the previous request and was abbreviated to accommodate the limitation on the number of characters which the request form will permit. Nonetheless, a new form is being submitted today with the preferred spelling as shown on KBHC's invoices. I strongly suspect that McLeod personnel will refuse or delay this request as well, unless ordered not to do so by senior management such as yourself.

This letter is to seek your assistance in ensuring that McLeod personnel promptly honor the request to transfer the numbers as the law requires. As you know, and as my October 23 letter explained, McLeodUSA has no legal basis on which to refuse to honor KBHC's request. It appears that prior refusals have been in participation and support of an attempt by PatriotNet to reassign one of KBHC's most important numbers, 800-SUICIDE, to another end user for remuneration. Further, as you also know and my October 23 letter explained, such reassignments are in violation of FCC rules and tariffs governing the transfer of toll-free numbers. The motivation for PatriotNet to attempt this unlawful transfer is obvious, as made clear by e-mail communications to KBHC from PatriotNet senior management; McLeodUSA's motivation to aid and abet PatriotNet in this effort is less understandable. Given the notice and explanation in my prior letter, any current violations of FCC rules and tariffs are knowing and intentional.

By calling this situation to your attention, I am hopeful that you will explain the law to McLeodUSA personnel and urge them to observe their lawful obligations as a RespOrg by honoring the request to transfer KBHC's toll-free numbers. If so, McLeodUSA likely will be free from any further involvement in this dispute. If McLeod instead chooses to continue participating in the effort to transfer KBHC's numbers to other end users, it likely will be dragged needlessly into further litigation and potentially jeopardize its RespOrg status. I hope that you are able to convince your company to do the right thing.

We represent the Substance Abuse and Mental Health Services Administration (SAMHSA), a component of the U.S. Department of Health and Human Services (HHS). We have reviewed the letter dated October 23, 2006 sent on behalf of your client, the Kristin Brooks Hope Center (KBHC) to Patriot Communications and McLeodUSA Telecommunications Services, Inc. We have also received a copy of your e-mail dated October 31, 2006 to Dr. Eric Broderick.

There are a number of issues raised in your letter and e-mail that should be addressed as expeditiously as possible. First, we note that KBHC advised SAMHSA on August 25, 2006, that the KBHC board had agreed to transfer 1-800-SUICIDE (800-784-2433) to SAMHSA in order to assure its continued operation. On that date, KBHC and Reese Butler agreed to relinquish control of the toll free number and to assign control of 1-800-SUICIDE to SAMHSA, consistent with FCC rules. Thus, on August 25, 2006, SAMHSA assumed financial and operational responsibility for 1-800-SUICIDE.

SAMHSA also agreed to assume financial and operational responsibility for certain other lines previously supported by KBHC and Patriot Communications, for the 30-day period following August 25, 2006. SAMHSA continued to support these lines beyond that period to enable a review of these lines and the services provided. SAMHSA intends to advise Patriot Communications that beginning December 1, 2006, it will cease supporting the following lines: (800) 773-6667; (877) 968-8454; (800) 472-3457; (866) 968-8454; (877) 838-2838; (877) 495-0009. Please note that Patriot Communications notified SAMHSA that it released the RESPORG for numbers (877) 968-8454 and (800) 773-6667 from McLeodUSA to Micktel Corporation earlier this month. SAMHSA will continue support for each of the following toll free numbers: (800) 784-2433, (877) 784-2432, (888) 784-2433, (800) 442-4673, (800) 827-7571.


Further, we understand that Mr. Butler has advised SAMHSA of potential or suggested routing changes for calls to certain crisis centers. Please provide specific information regarding these requested changes and we will forward this additional information to SAMHSA for review.

Finally, SAMHSA remains willing to settle all disputes with regard to cost-related claims under Grant #U79 SM 54127, awarded by SAMHSA to the American Association of Suicidology (AAS). 
