Dear Ms. Dortch:

This letter is filed on behalf of Curtis Telephone Company, Inc., Total Communications, Inc., and Consolidated Companies, Inc., and corrects an inadvertent error in the "Application for Transfer of Control" (the "Application") filed with the Commission on December 18, 2006 and provides an update on the status of the transaction.

On page 7, Section 12, of the Application, the reference to the residential access lines for Curtis Telephone Company as being "516" is in error. The correct number of residential access lines as of September 2006 that should have been stated is "554."

A description of the transaction is contained on pages 5-6, Section 6, of the Application. Since the time of the filing of the Application, the necessary approval by the shareholders of Curtis Telephone Company, Inc. ("Curtis") for the transaction has been obtained. In addition to the requisite shareholder approval required for the transaction, there were no shareholders of Curtis who sought to exercise any "dissenter's rights" provided under state law with respect to the transaction. Accordingly, subject to receipt of regulatory
