
Dear Ms. Dortch:

On behalf of Denali PCS, L.L.C., Alaska DigiTel, L.L.C. and General Communication, Inc. and pursuant to Section 1.65 of the Commission's rules, the Commission is hereby advised that the Services Agreement between Alaska DigiTel, L.L.C. and SprintCom, Inc. that was previously provided to the FCC has, pursuant to the terms thereof, been extended for a period of one hundred eighty (180), from December 15, 2006 to June 13, 2007. The agreement has not been renewed, but rather the post-termination transition period contemplated by Section 5.1 has been initiated.
